

## Loan of Studio Lights - AGREEMENT

I, \_\_\_\_\_ (referred to as the Lessee) I.D. Card No \_\_\_\_\_ accept to borrow the studio lighting system from the Malta Institute of Professional Photography (MIPP) under the following terms and conditions:

- 1) The sum of €200.00 is being deposited as security and will be used to cover part or full cost of any damage expenses. If the damage is greater than 200 Euro, the Lessee must cover any additional damage and labour costs.
- 2) The cost of the set of lights being loaned is of € 45 per full day of use - (pickup and delivery days are not to be accounted for).
- 3) Should the lights not be returned on the designated day, the Lessee is liable to penalty costs of €45 per additional day.
- 4) In failure of paying the full amount of money the MIPP reserves the right to seek legal action and suspend the member's membership with MIPP.
- 5) The Lessee undertakes to accept the loaned equipment and take good care of it, returning it in the same manner and condition that it has been handed over.
- 6) The MIPP is not responsible or liable to any damages whatsoever when the lights are being used by the Lessee or any third party while the equipment is in the Lessee's responsibility. The equipment is loaned out at the Lessee's own risk.
- 7) The equipment cannot be loaned to third parties.
- 8) Should any part of the kit be damaged whilst in the Lessee's keep, the equipment is to be immediately returned and any repairs will be done by the MIPP at the Lessee's expense as indicated in this agreement.
- 9) The Lessee is to make sure to have read the **instructions for use** which are to be given to the Lessee on signing of this agreement.
- 10) A photocopy of the Lessee's ID card is to be given to MIPP on signing of this agreement.
